#### 4. Deanery Update

- Visitations. Revd. Tessa Stephens (TS). Thoughts on the Parable of the Talents. The visitations (spring-summer 2023) highlighted the amazing resources and hard work of those who prepared for the Archdeacon's visitation. Are we all using what we have for the best? It's not about how much you have, but what you do with it. Thanks given to all involved and it's another 5 years until the next visitation.
- Living Christ's Story (LCS). John Dickinson (JD). Although the plan itself has not progressed very far, individual parishes have done good work that meets the criteria of LCS (Becoming more like Christ · Reaching people we currently don't · Growing churches of missionary disciples · Transforming our finances and structures.) Our response is to share the good news of what we *are* doing. The leadership of the Diocese appears undecided about the way they will lead and coordinate the Deanery plans. There is, as yet, no date for the next implementation and coordination group meeting. We are working within parishes throughout the Deanery on initiatives under agreed LCS objectives and principles. However the plan calls for working collectively, which appear a step too far at this point. Working to the plan is an unnecessary burden compared to simply sharing what we are doing and learning from each other. This is the way we intend to move forward.

#### 6. Finance Update (Bob Ardley, Treasurer)

- The Current Account balance is £2648.03
- 16 (out of 20) parishes have paid the Deanery levy. One incorrect e-mail address now corrected.
- Book grant cheques for all Readers have now all been cashed.
- Cheques for Authorised Lay Ministers (ALMs) created in September have now been issued. 7 have been distributed, 2 of which have been cashed.
   ALMs are encouraged to cash these, before the end of year accounts (31st December).

### 7. Deanery Financial Advisor (DFA) Update (presented on behalf of Ken Taylor by TS).

- Most of the Freewill Offers for 2024 have been submitted to the Diocese- 7 parishes have increased, 10 have remained the same as 2023 and only 1 has reduced [Carlton]. This may sound encouraging, but the overall increase is only around 1.5% so we are not yet, as a Deanery, back to the pre-covid level of giving.
- A number of parishes have not yet submitted their accounts for 2022- we are asked to do this as soon as possible please.
- 4 parishes were the recipients of the enhanced card readers as part of the recent "Digital Rollout" by the Church of England. These are a big improvement on the older models and hopefully will encourage especially visitors and occasional givers to use them more.
- We will be having another meeting of treasurers on Wednesday 8<sup>th</sup> November at 3pm in the Stainton Church Room. Please encourage as many treasurers as possible to attend. We will be pleased to have both our Clergy and Lay deanery leaders present!

# Attachment 2 Benefits of a parish/ benefice administrator Revd Laura Wild and Liz Taylorson

### The Person:

- Consistency of service especially during vacancies
- Allows church to be open and responsive to enquiries
- Often local knowledge/familiarity within the Parish

# The tasks:

- Triage of general enquiries, and dealing with routine tasks, freeing up clergy time.
- Managing expectations enquiries will be answered at consistent office times.
- Contributing to the legalities of ascertaining ID for banns/wedding enquiries.

# The place:

A physical hub, that isn't (necessarily) the vicarage, with photocopier, etc.
 staffed at consistent hours (including in clergy absence); a welcoming,
 functional space.
